SUPERINTENDENT REPORT:

Superintendent Baumann did not have a report at this time.

COMMITTEE REPORTS:

Trustee Little updated the board on the facilities and safety committee meeting. There are several projects scheduled to take place during the spring recess. Trustee Kennedy met with the curriculum committee where each building gave a report on programming. The elementary spoke of Eureka Math, the middle school is using the inquiry method in the sciences and social studies for writing, and the high school is working on how to help struggling students in the algebra I class. She also reminded the board of the NOSBA program being held on March 10.

NEWFANE TEACHER'S ASSOCIATION REPRESENTATIVE:

H. Kursten, President, shared a statement outlining programming history from the NTA view. He mentioned specific curriculum and extracurricular cuts and changes from 1990's to now. Mr. Kursten stated that the one constant in the district is that the teachers continue to work, with less assistance and class offerings.
