Location of Assignment	Newfane Elementary School – Aquatic Center
Days/Hours of Assignment	Monday – Friday / 9:00 AM – 3:00 PM 10-month work year (Sept – June, annual appointment)
Job Description	The Chief Lifeguard will protect the safety and well-being of each patron (child, adult, or student) using the Newfane Central School District’s swimming pool, provide aquatic instruction as assigned in a developmentally appropriate manner, work directly with all pool participants providing courteous, friendly, and professional level assistance. The Chief Lifeguard reports directly to the building principal.
Responsibilities	Serves as a pool lifeguard; assists PE teacher with instructing classes in the fundamentals of swimming; supervises swimming activities in and around the pool and pool deck area; ensures that all policies and regulations are observed and enforced and that no hazard to safety is created; warns swimmers of improper activities or danger; rescues swimmers in distress or danger of drowning; administers first aid in the event of an injury; administers artificial respiration, if necessary; work additionally for community programs and American Red Cross Learn to Swim. Routinely adheres to and maintains a positive attitude toward the District and aquatic programs; performs other related work as required.
