## SUBSTITUTE TEACHING APPLICANTS

If you do not already have an account, you will need to create one and complete a <u>Certified</u> application regardless of whether you are NYSED certified or not. Please be sure to **list three (3) references** with contact information on your application. You will also need to **upload a letter of interest and resume**. Once your application is complete and your documents are uploaded, you must **apply** to the Newfane Central School District's posting for Substitute Teachers within the Applicant Tracking system.

## IMPORTANT ITEMS TO NOTE:

- All substitute teaching applicants must complete the fingerprinting process and receive clearance through the New York State Education Department (NYSED) prior to being recommended for appointment by the Newfane Board of Education. If you have not been previously fingerprinted, specifically through the NYS Education Department, please visit the following site to schedule an appointment: <u>http://www.nysed.gov/educator-integrity/fingerprinting</u>
- Substitute interviews will be scheduled periodically throughout the school year. When a date has been determined, you will receive an email from Peter Young, Director of Curriculum, Instruction, Assessment & Technology, which will include the date, time, and location of interview as well as additional documents you will need to bring.
- Per diem substitute teachers are paid based on certification status. Teacher certification is preferred. The rates of pay for the 2023-24 school year are as follows:

Uncertified Substitute Teachers = \$100/day Certified Substitute Teachers = \$120/day Certified Long Term Substitute (if assignment is determined to be more than 10 days) = \$130.00/day
