SPECIAL EDUCATION/STUDENT SUPPORT UPDATE:

Jennifer Bower, Director of Special Programs, updated the Board of Education on the function of the Special Education/Student Services department including staffing, student placements, comparative data and challenges.

PRESIDENT REPORT:

SUPERINTENDENT REPORT:

Mr. Baumann updated the Board of Education on the following: County/District COVID update: The Niagara County Health Department indicated that the numbers have not changed much, more testing so more positive cases, more people are exhibiting flu like symptoms, children and vaccinated adults show mild symptoms or no symptoms at all. Hospitalizations and deaths are down in the county. In district, 2 students

Hospitalizations and deaths are down in the county. In district, 2 students tested positive, 6 students are quarantined.

The NYS Department of Health issued a document on "test to stay" option for students, this would allow students to test daily to stay in school. Mr. Baumann is not an advocate for this practice as the district does not have enough tests and the testing should not fall on families to provide. He

advocates for continuing with current practices and procedures. This is in alignment with Niagara County.

Mobile Testing Option: The county along with districts have issued an RFP for Mobile Testing. The logistics are being discussed but Newfane District is able to continue our practice of inhouse testing, it is working well. Discussion took place as to whom is eligible to be tested in district, residents would be able to if working in other districts as needed. They would need to arrange this with Mr. Baumann.

Athletics: Masking for athletics is not completely decided. At this time the guidance that we have says all athletes need to be masked at all times. This is not possible for sports such at swim and is still being decided for the winter sports season.

COVID Clinic: The Niagara County Health Department is anticipating pediatric vaccines being approved and available very soon. They are requesting use of an area in district to hold a vaccination clinic for boosters and pediatrics, much like what was held last winter. The Board of Education did not object. Capital Project Update: Bid openings next week which will be on the November 16 agenda for board approval.

Trustee Kennedy shared the minutes from the Health and Wellness Committee meeting. The committee addressed some very important questions and concerns of the district. Mrs. Kennedy also shared an update on NOSBA and planning for future events.
