The Chief Lifeguard reports directly to the Building Principal.
Responsibilities:	Serves as a pool lifeguard; assists PE teachers with instructing classes in the fundamentals of swimming; supervises swimming activities in and around the pool and pool deck area; ensures that all policies and regulations are observed and enforced and that no hazard to safety is created; work additionally for community programs and American Red Cross Learn to Swim. Routinely adheres to and maintains a positive attitude toward the District and aquatic programs; performs other related work as required.
